

Privacy Policy

We are committed to safeguarding the privacy of the Los Angeles Academy of Figurative Art's visitors and service users on www.laafa.edu. This policy applies where we are acting as a data controller with respect to personal data. We also use cookies on our website. We will ask you to consent to our use of cookies when you first visit our website.

Usage Data

Usage data may include: IP Address, geographical location, operating system browser type, length of visit, referral source, page views, timing, frequency and purchases. The data collected in this way is anonymous to us, i.e. we do not see the personal data of individual users. Google Analytics and Facebook provide the data we collect. We use this information to serve you better. The extent of information we collect will depend on your personal settings while on our website. Account and Profile Data

The account data may include your name, phone number and email address. If you choose to create an account with the Los Angeles Academy of Figurative Art, we use this information to send your email regarding account changes, password resets, email registration confirmations, notification on course changes or offerings.

The profile data may be used to monitor your use of our website and services. If you create an account, we will store your name, address, email phone

number, which can be used for future registrations. In addition, if you choose to leave comments/reviews these actions will be stored.

Payment Data

The Los Angeles Academy of Figurative Art uses PayPal to process registrations made on our website. Some of your data may be passed to PayPal to complete your registration. The Los Angeles Academy of Figurative Art does not store your credit information in our database. Information given to PayPal is encrypted and maintained by the payment processor. Email Service Provider

As part of the services offered by the Los Angeles Academy of Figurative Art, we use your name and email to inform you about school news content. To provide you with information about our school, the Los Angeles Academy of Figurative Art stores your name and email address with our email provider MailChimp and GoDaddy. Retaining and Deleting Personal Data

Children's Privacy

GDPR Policy Rights
