 - According to the program, funds received by LAAFA were to be distributed to students with "exceptional need". Since all enrolled students had completed the FAFSA, LAAFA determined those students with highest need based on all FAFSA's with a 0 EFC. From there, we evaluated need based on additional outside costs from LAAFA's Cost of Attendance
- 7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants.
 - LAAFA instructed our students that the Emergency Financial Aid Grant Funds are available to help manage their expenses with regards to working online.
